Feis Cruise General Conditions

Deposit & Payments: The following deposit is required to secure confirmed accommodations. Deposit must be received within 7 days of making reservation. Early Deposit of \$ 100 per Stateroom is required by August 20th – 3pm. For this initial payment, you need to send a check, money order or request an e-invoice to arrange a direct transfer to Mochara Intl Account. Deposit can be by PayPal Acct: res@mocharaintl.com. You may make payments before the Final Payment date, Final Payment is due by April 15, 2019. Payments can be made by check, American Express, Visa, MasterCard or Discover. Credit card payments require a Credit card authorization form to be filled out.

Cancellation & Refunds: For most cruises and tours, a full refund (except for amounts paid for Travel Insurance) will be made for written cancellations received by Mochara International/Norwegian Cruise Lines at least 121 days before the date on which you are to commence travel (by air, rail, sea or otherwise). Travel Insurance is always recommended. Norwegian Provides their own Insurance plan called Booksafe Travel Protection Plan. Other Insurance options can be seen at: <http://www.mocharaintl.com/travelinsurance.html> Passengers, who cancel after that date for any reason, including medical or family reasons, are subject to the following per-person cancellation fees before Voyage for Cruise, Air, Land or Addons:

- 119 – 91 days: 25%
- 90 - 61 days: 50%
- 60 – 31 days: 75%
- 30 or less days: 100%

For certain cruises and tours, different cancellation policies apply. Please consult the brochure for your cruise or tour to confirm the applicable cancellation policy. Given that the resales of cancelled space will likely result in a lost opportunity to sell other space, these fees are due regardless of resale. Fees incurred as a result of cancellation cannot be applied to future bookings. Refunds will normally be made to your travel agent. Travel agents may impose their own cancellation fees. Agency fees of any nature are a matter to be decided on solely by the agency and passengers.

Name changes require the prior approval of Norwegian and may not always be possible. Cruise and Cruise Tour Contracts are nontransferable..

Cruise Rates: Government taxes and fees are not included in the cruise rate. Airfare is additional. Taxes on airline transportation, air transportation, shore excursions, medical services, items of a personal nature—such as bar beverages, gift shop purchases, beauty salon/ barber shop & massage services, gambling and shore excursions -are not necessarily included in the cruise rate. The amount of taxes and charges specified herein are subject to change. Norwegian reserves the right to pass through to the guests any increases which become effective after the printing of the brochure.

Service Charge: Norwegian 's crew works very hard to make sure that every aspect of your cruise meets the highest standard. To ensure that the efforts of the Norwegian crewmembers are recognized and rewarded, Norwegian automatically adds a service charge to your cabin account. If their service exceeds or fails to meet your expectations, you are free to adjust this amount at the end of the cruise.

Clothing: Casual attire is in order during the day. For two nights, a dark suit or formal attire is suggested. The dress code for other evenings ranges from sport coat and tie to casual resort wear.

Passport Data: US Immigration determines the correct documents, which guests must have in their possession in order to travel. Proper travel documentation is required throughout the cruise and is the responsibility of the guest. Any guest traveling without proper documentation will not be allowed to board the vessel and no refund of cruise fare will be issued. Documents must be presented at time of embarkation. All non-US citizens must surrender their passports and/or green cards and these documents will be returned by Immigration upon arrival back in the US. US and Canadian guests need proof of citizenship (Passport). You may also use a Government Issued ID like a State Driving License and a copy of your certified Birth Certificate. The Names on both documents must match exactly. If your driver's license is issued in another name versus your Birth Certificate, then you must provide certified copies of a marriage license, etc that validates the change in Name. Also, there are new requirements by TSA on Driving licenses issued by the Individual States. Some states might not have updated their format in time for the cruise or one issued already does not include the new requirements. Easiest and best option is to use your US Passport. Resident Aliens need both a passport and an Alien Residents Card. Non-US Citizens need a valid passport and a valid unexpired US multiple Re-Entry Visa. Non-US Citizens eligible to apply under Visa Waiver Program must have a valid unexpired Passport. You can check with the information on www.ncl.com, your local consulate or TSA to see what is required if you have a different situation.

Minor Guests: Guests under the age of 21 years must be accompanied by a parent, grandparent, or guardian 25 years or older in the same stateroom. Infants must be at least 4 months old to be eligible to travel. Norwegian offers supervised activities for children 2-15 with limited activities available for 16-18 year olds.

Responsibility: MOCHARA INTERNATIONAL neither controls, nor operates, nor is responsible for the actions of independent Contractors such as cruise lines, airlines, railroad companies, tour operators or ground transportation. You are responsible for arriving at the respective ports on time for embarkation and for joining the vessel at its next port of call if for any reason you miss a schedule sailing. Norwegian reserves the right to refuse or discontinue passage to anyone when in Norwegian 's judgment; it would be considered a risk to the guest's own safety and well-being or the health, safety, well-being comfort and enjoyment of any other guest or crewmember.
